

Activity Participation Liability Waiver

Participation in some Pottawattamie Conservation (PC) related activities requires signing the following liability waiver. PC-related activities include but are not limited to outdoor recreational activities, assisting with land management activities, and conservation-related educational opportunities. Participation in PC-related activities may however present a variety of inherent risks to the health and safety of the participants including but not limited to:

- Difficult/hazardous terrain
- Adverse weather conditions
- Dangerous or harmful flora and fauna
- Physically strenuous activities
- Motorized vehicular travel including utility terrain vehicles (UTVs)
- Use of a variety of power tools
- Land management activities including prescribed fire or use of herbicides/pesticides
- Exposure to contractible illnesses that may result from direct or indirect interaction with others (e.g. COVID-19, influenza A and B, etc.)

Your participation is voluntary and you assume the risks associated with PC-related activities. By signing this waiver, you acknowledge that:

- You understand the risks associated with PC-related activities.
- You take responsibility for all risks for yourself (and any minor children you may bring with you) for any bodily injury or property damage resulting from your voluntary participation in this event.
- You agree to provide any and all personal protective equipment (PPE) for yourself (and any minor children you may bring with you)
 appropriate for the activity performed.
- You agree to conduct yourself (and any minor children you may bring with you) in a safe and reasonable manner.
- PC reserves the right to restrict you (and any minor children you may bring with you) from participating in any activity(s) deemed to be a danger to the safety or well-being of any person or property.

I voluntarily assume any and all liability for the risks involved in PC-related activities and agree to release, discharge, indemnify, and forever hold harmless Pottawattamie County, its officers, agents, employees and volunteers harmless from any and all liability, claims, demands or causes of action for me and my minor children for any injuries or damages arising out of my participation in PC-related activities.
